Welcome / Call to Order / Introductions

Approval of the agenda: Michael Darger opened the meeting with approval of the agenda. Notie moved approval. The agenda was approved as presented.

Review & Approve February 14, 2014 minutes: A draft has been sent out but is still incomplete. Approval deferred until May meeting.

Treasurer's report: Notie indicated that the financial reports were distributed to the Board. Membership renewals are coming in. We received final payment from Galaxy, which will be credited to 2013 financial statements. Cash on hand is roughly \$120,000. The April Treasurer's report will be filed for audit.

- Worked with NE awards committee and have submitted final scores to Michael Dougherty. All five proposals will be submitted to National. Daniel Eades will represent our region nationally.

North Central Josh Clements

Report submitted online:

- I have been fielding inquiries from members in the North Central Region regarding the Annual Conference, predominately when the agenda will be posted and registration will open. I have been forwarding what I know, and shared the hotel reservation information widely the week of March 25.
- I attended a conference call of the Missouri NACDEP State Affiliate organized by Richard Proffer (previous NC Rep) on March 31.
 - There were 8 10 folks online.



- I provided a 5-minute overview of the last Board goings-on
- I provided the latest news on the Conference
 - People were becoming anxious over not hearing anything about conference agenda or program, other than
 the little that is online.
- Regional award reviews completed on April 10th (three days late) and forwarded to the Awards Committee. There were 25
 award submissions. Each category but two yielded recommendations for regional award and forwarded for National
 consideration.

Concerns:

Cost of attendance. However, Park City was perhaps comparable costs and attendance/feedback was generally good.

Do not know if the hotel quotes have been negotiated (probably not)

Might be able to fly into another (larger) airport and drive or shuttle



Discussion: Do we have May or June conference? May might be lower costs for flights and hotels (off-peak), but UVM could be in session and thus use of dorms would be out (as potential low-cost option). June would mean people could take families for a vacation, but this has not been an active emphasis of NACDEP (as it has for Ag).

We've had our conferences at conference hotels – what about having conference on campus?

Mixed bag. Facilities might not be centralized, inconsistent. Difficult to coordinate. Might be lower cost. Housing might be difficult with people staying in a variety of places, then transportation to/from.

Josh: UVM Conference facility banquet hall / ballroom would not have sufficient capacity (~200, seated; we need ~600 with joint conference).

Could we go with host conference hotel, with dorm option? Yes, we could look into that arrangement. Those who want and can afford hotel "would likely" go that route; having dorm option might expand our attendance.

Unanimous decision to move forward with Vermont

Committee will continue to investigate hotel, with dorm option. Sheraton appeared to have edge (as it is by campus) rather than Hilton (downtown, about a mile away).

New Business

Report from exploratory committee with CDS

Michael Darger

- Joint committee thought the only option for a joint NACDEP-CDS conference would be 2017- if it would be in the Western Region (Montana? Portland or Seattle were also mentioned by CDS). CDS looks for "hub" cities for international members to make travel easier and attract them.
- Paul LaChepelle, a joint NACDEP-CDS member, has already volunteered to host in Montana.
- Do we want to consider doing collaborative conference at that time?
- North East and West are hardest places for us to have conference, so if financials are sound and conference structure is good to preserve
 our culture, we can leverage larger group to make the conference work.
- This would allow some of our members that are dual members to save costs.
- Mary: In the past, CDS "takes a bath" whenever it hosts a conference in the West (not a lot of members in that region).
- Suggestion: Create survey to NACDEP membership to assess their interest the possibility of joint conference
- Peter: Most people will not know how to respond to this potential, unless they've attended CDS conferences in the past.
- Josh: Having CDS and NACDEP hosting conferences in the same region (North Central) and same year seems to be effectively splitting attendance with people (that I've heard from) that can only attend one conference due to time or expense. Hosting a joint conference in a region that each organization has few members may be a way to increase likelihood of good attendance and overall success.
- Discussion regarding a full membership survey, which could include question of joint conference with CDS. Stacey willing to assemble this survey. Josh will work with Stacey.
